4. MS4 Update – Tohickon and Unami Creek Restoration

Township Engineer Mike Schwartz will present an update on the MS4 stream restoration projects for the Tohickon and Unami Creeks.

Mike Schwartz stated the MS4 is the Municipal Stormwater System so it's soils, pipes, retention basins, any of those systems that are within the census area of the Township. It is not the entire Township, but it is an area defined by DEP. The MS4 permit is the maintenance and protection of the stormwater system. The Township MS4 is in two watersheds, the Tohickon and the Unami Watershed. The Tohickon was first and to satisfy the pollution reduction plan which the Township was required to prepare as part of the last MS4 cycle, each cycle is a 5-year permit timeframe; to reduce sediment to DEP standards for the pollution reduction plan we proposed a stream restoration project on the Tohickon. The project area is along the property line of Old Castle and the new MRP Warehouse facility that is currently under construction. What we did was approximately 1,000 feet of stream bank restoration, which involved removing dead and invasive species, doing slope grading on the edge of the slope, proposed some toe protection of the stream channel, which is putting larger diameter rock to help prevent erosion during higher velocity storms, and replanted those areas with native vegetation which will help reestablish the streambank. All in hopes of reducing erosion and sediment pollution downstream and in the Tohickon.

Tim Arnold asked if that was Phase One. Does the DEP come out and inspect each phase as it's completed?

Mike Schwartz said during the process the Conservation District was there and the Conservation District had a waterways specialist that was in and around the site during construction. DEP Officials have not seen it. They wanted to but the Township had an MS4 Audit on July 17th that Jim Benner and I took part in. That was for the entire MS4 covering the permit in its entirety including the restoration projects. The Tohickon project is very grown in and it was decided they would not tour the area. They were very pleased with the pictures. We took pictures throughout the construction process. My office went out in March and July. We took pictures at the beginning of the growing season and then with vegetation taking.

Tim Arnold said let's talk about the Unami. The Unami is over by Brighton Gardens, correct?

Mike Schwartz said it is right off the Blue Heron Park in Brighton Gardens. That was a much shorter restoration project. It's technically a stream that comes from Brighton Gardens. What we did was similar, we cut the slopes back on the edge of the banks, live stakes with native plantings, took out evasive plants, some large trees and cleaned up some of the dead. Part of the permit, there are six minimum control measures, one of them is public education and that is this. Speaking annually satisfies public education. On the website we include DEP materials that talk about when it rains it drains. Be cautious of where the water runoff goes. It goes into our systems and into the creeks and waters. As it stands, we are waiting to hear back from the Audit. We replied to some initial comments. The Townships obligation is to continue to work towards addressing the 6 minimum control measures and one that I anticipate coming back is doing some inner office, inner Township education like speaking with the Road Crew. That should be done annually. DEP provides programs or my office could sit down and go over it with them.

Tim Arnold said over a half million dollars of taxpayer money was for this. Leslie, was any of this half million dollars reimbursable by the Federal Government or the State? Leslie Huhn said we used some of our ARPA funding to cover this so as not to use tax dollars.

Mike Schwartz referenced pictures and said the Unami is a very small waterway. In his experience, it is constantly running. You can jump over it compared to the Tohickon. Not a lot of people will see the Tohickon project, but it does look good, and you can see the work area on Google Earth. The one thing Leslie is aware of for next year's budget, you will need to budget for outfall screening. So, we will have to do all of the dry flow screenings of all of the outlets in the Township, which we did during the last 5-year cycle and we will have to do during this current 5-year cycle.

5. Tollgate Landing Trail – Approval of Easement Agreement

An Easement Agreement has been prepared between Richland Township, Milford Township and the Tollgate Landing Homeowner's Association. This agreement is required for the Appalachian Mountain Club to secure grant funding.
